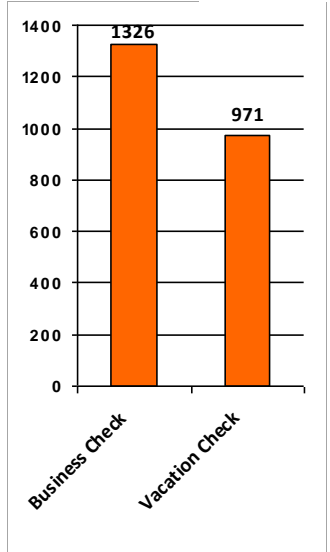
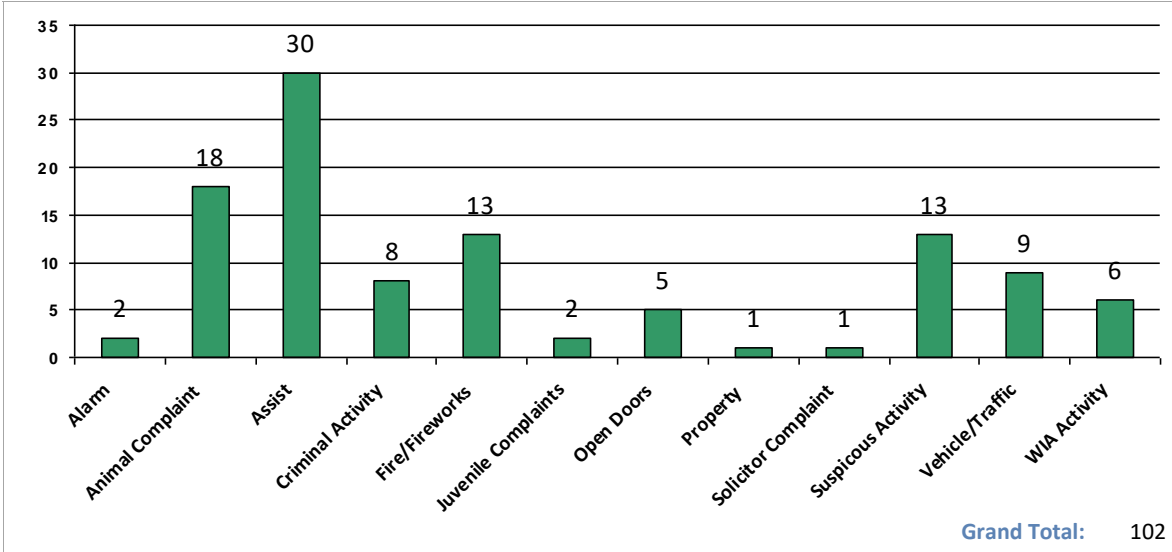

Attempted contact and could hear what sounded like teenagers upstairs. After several attempts to make contact and no one coming to the door, I left the violation notice on the front door. In determining the correct address, I saw some aerial fireworks coming from behind a house while at the RP's address (1425 Bowstring Road). I then walked down the side of the property to see the backyards. Looking east I saw people on a deck, lights went on and off several times then in the darkness I observed 20 aerial fireworks being set off from the deck. In the darkness, I accepted the RP's statement they were coming from two houses east, wrote the violation notice and contacted the resident at that address. It was determined that 1395 was the wrong address after the homeowner allowed me to go into the backyard and seeing there was no deck. From that backyard, I could see the deck immediately east at 1375. I apologized to the homeowner at 1395 and then went next door to 1375.
