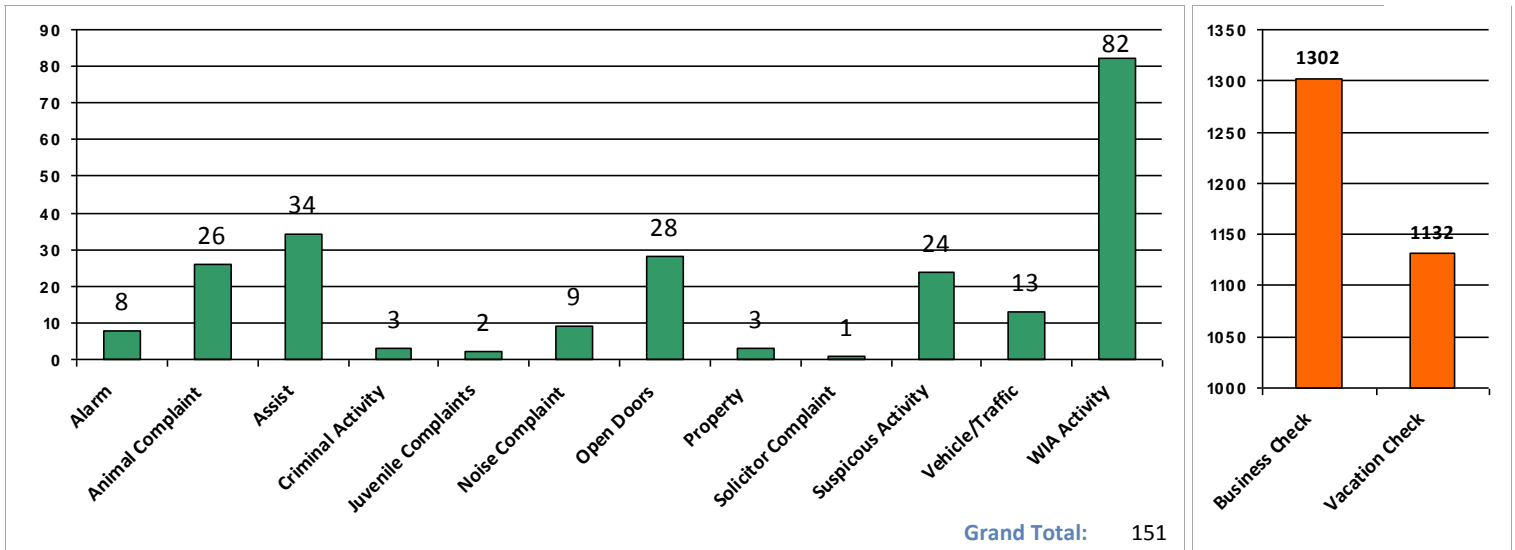

PID 5099 did not have her license but provided registration and an outdated insurance card. I advised them that any damage caused to the property (tree and median) may result in a claim filed against her insurance company. While we waited for CSP to arrive, her husband was attempting to cut a branch from the tree and again, I asked him to stop, he complied. CSP arrived and investigated.
