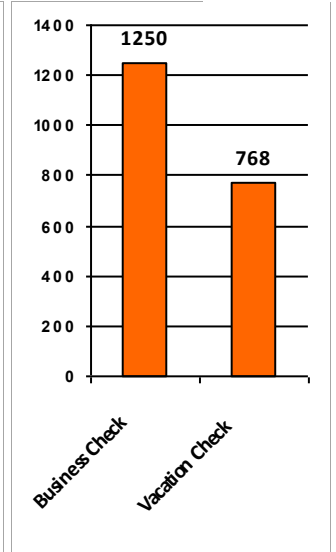
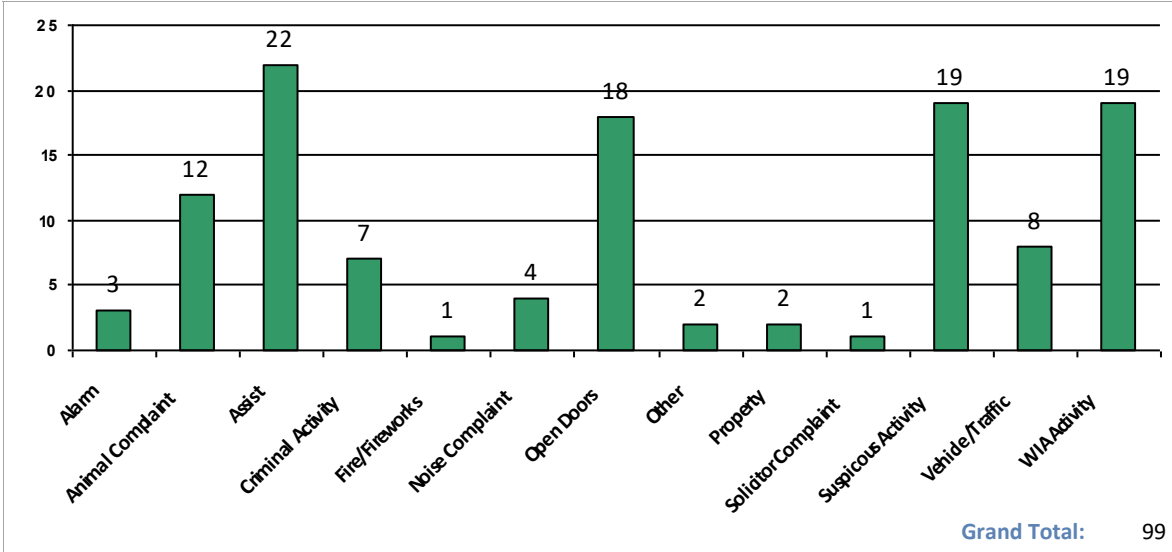

She explained to me that she had suffered an injury from a recent procedure that causes neurological issues and involuntary movements in her body. She continued to explain that she often suffers from "episodes" of severe involuntary movement and needs to get out to walk around to help calm the episodes. She stated she is not a resident of Woodmoor, but is familiar with this area and feels safe being in this spot during her episodes. She also stated that she will often walk in the grass field at Lewis Palmer High School. While speaking to Aubrey I did not observe any signs indicating intoxication of any sort. She had recently lost her job due to this condition and along with that a loss of insurance to help with medical care. She left the area soon after our conversation, and I informed multiple concerned residents in the area of the situation. In my opinion, I did not see her as a threat to Public Safety in Woodmoor, but as someone struggling with a tough situation. I did not ask her to leave the area, because I believed this spot was important to her to help with her struggles. After speaking with the RP and residents in the area they welcomed her presence.
